#### DESCRIPTIF

This idyllic property is located near a small village. Perfect for a life change.

The environment is changing and solidarity, a positive state of mind and a relaxed attitude are natural.

This magnificent property is suitable for tourist rentals, but also for events, co-housing and for simply hosting families and/or friends. An extension in the form of a workshop of 75m² is possible. Set in 2 hectares of land with views over the countryside and mountains, it is right in the middle of nature.

The property is ready to be used as a home or as a business. This property of 3 buildings (137m², 253m² et 62m²), has 7 bedrooms and 7 bathrooms, distributed in such a way that they can be used in different configurations, as needed. There are 6 living rooms and 6 equipped kitchens. Separately, there is a professional kitchen and a large multi-purpose area.

A magnificent canopy with a high roof level provides a friendly sheltered terrace area and access to the main house. The large living room (26mé), kitchen (12m²) and shower room are located on the ground floor and the 4 bedrooms (12m², 21m², 9m² and 11,5m²) are accessible on 2 different levels. One room is equipped with a sauna. Then there is the entrance to a separate dwelling in the same building, with a living room/bedroom (37m²), kitchen and shower room (5m²). In front of this house is a lovely shaded terrace.

This building also has a large workshop  $(75m^2)$ , in which the pellet boiler is installed. This space c








