This property is located in Sainte Marie de Ré, a nice village with all amenities and lovely sandy beaches on the south part of the island.

La Rochelle airport, train station and historic centre are reachable within 30 minutes but also by bus from the Sainte Marie.

DESCRIPTIF

Built in the 1800s, behind a majestic gate, this is the last house on the island to have retained its decorative, listed façade.

The house offers an open-plan living space, divided by a central staircase, with plenty of natural light and beautiful parquet flooring. There is a 14.74m2 lounge, a 25.95m2 dining room and kitchen and a toilet.

The semi sous-sol comprises an entrance hall (10.5m2), two bedrooms (10.30 and 12.43m2) and a bathroom with toilet (7.67m2). Upstairs you'll find a cosy mezzanine area (8,8m2) with a bedroom (8,15m2) and a shower room (4.75m2).

The exterior is an enclosed courtyard with a pond and a shed offering a beautiful decked terrace to enjoy the lle de Ré climate most of the year.


